

Cream to Powder Blush/ Eyeshadow

Method

1. Blend phase A in an appropriate vessel and grind in a grinder until uniform colour.
2. Sieve in phase B and grind in short bursts (circa 2-3 times).
3. In a separate vessel combine phase C and heat until melted.
4. Slowly sieve step 2 pre-mix into phase C and mix until smooth and uniform.
