Preparation procedure

- 1. Blend Phase A in an appropriate vessel and grind in a grinder until colour is uniform.
- 2. Combine Phase B and slowly and gradually add it to Phase A, whilst grinding in short bursts. Mix if needed.
- 3. Add Phase C and grind in short bursts until uniform. Do not overgrind.
- 4. Sieve the powder mixture and press into godets.
